# Evan. Lutheran Synod of North Carolina.

According to a resolution of adjournment, adopted at its last meeting, the EVANGELICAL LUTHERAN SYNOD OF NORTH CAROLINA, convened in St. John Church, Cabarrus Co., N. C., on Wednesday, April 28, 1875, at 10 o'clock, A. M. The opening sermon was delivered by the President, REV. S. ROTHROCK, from Acts 20: 17, 20, after which Synod was opened by the President, in accordance with our prescribed form.

Synod being now organized, the President read his report, which was laid on the table for further consideration.

#### President's Report.

#### DEAR BRETHREN:

"Grace and peace be multiplied unto you through

the knowledge of God, and of Jesus our Lord."

It is source of devout gratitude to Almighty God, that we are permitted to assemble again in regular Synodical meeting. We always look forward to our annual conventions with pleasing anticipations. An opportunity is then afforded for the interchange of fraternal greetings and Christian salutations. We can then socially and mutually review the events of the past year, and unassumingly communicate the results of our toils and labors, in the great work committed to our trust. Although some of our ministers have, in a few cases, been compelled, in consequence of physical infirmity, to yield to a temporary cessation from labor, it is nevertheless believed, that our ministers, as a body, have enjoyed good health, and have been able, with but little interruption to prosecute their work with successful progress as "embassadors for Christ." But we meet, not simply to interchange social greetings and kindly feelings, but to devise scriptural plans, and mature wholesome measures, for future operations in advancing the spiritual interests and prosperity of our beloved Zion. As the duties, which will claim our prayerful deliberation during our present session,

are of a very momentous nature, we should devoutly invoke the enlightening and directing influences of the divine Spirit to lead us into all the truth.

It now becomes my duty to present to you a report of my

official acts during the past year.

In accordance with a constitutional application, a special meeting of Synod was called. which convened in St. James' Church, Concord, at 10 o clock, A. M., on Saturday the 25th day of last July. The object of the meeting, as set forth in the call, was the examination of Mr. J. H. Harry, with a view to his ordination, and also his installation as Pastor of the Concord Pastorate. A quorum being present at the time and place appointed, the Ministerium entered upon the examination of Mr. Harry. The examination having been sustained, it was constitutionally voted that he be ordained on the succeeding day, (Sunday,) in St. James' Church. In compliance with the action of the Ministerium, Mr. Harry was duly ordained by the officers and other members of the Synod, according to the form prescribed in our "Book of WORSHIP," and thus regularly inducted to the GOSPEL MINISTRY, and admitted as a member of this Body. In the afternoon of Sunday, after an appropriate sermon by Rev. N. Aldrich he was regularly installed as Pastor of the Concord l'astorate. The Minutes of said special meeting will, no doubt, be handed in by the Secretary to be incorporated with the Minutes of our present meeting.

On the 9th of last June, the report of the class-standing and conduct of Mr. R. W. Petrea, for the half-session ending May 27th, 1874, was forwarded to me by Rev. L. A. Bikle, D. D., President of N. C. College. Mr Petrea has been receiving beneficiary aid from this Synod as a Theological Student, and the report, which is herewith submitted, indicates commendable progress in study, and very exemplary

deportment

On the 22nd of last August, the corner-stone of a new church was laid in Davie county, the contemplated church being designated, Cherry Hill Evangelical Lutheran Church. The carpenter work of the edifice has since then been completed, and the edifice will, at no distant day, be ready for consecration to the service of Almighty God. This church is located in a densely populated community, and the prospects for an increase of membership is very encouraging.

· Three new houses of worship have been set apart and consecrated to the service of God, during the past year, viz.:

(a) Christiana Evan. Lutheran Church was consecrated on the 30th of last August. This is a frame building, eligibly located some six miles South of Salisbury, of very commodious dimensions, is very neatly finished, and speaks well for the zeal and liberality of Pastor and people.

(b) St. Enoch's Evangelical Lutheran Church was conse-

crated on the 20th of last September. This is a substantial brick edifice, located in the south western part of Rowan Co., of capacious size, is very tastefully arranged, and is an impressive memorial of the active and self-denying piety of the congregation.

(c) Bethel Evaugelical Lutheran Church was consecrated on the 29th of last November. "This is a very neat frame building, 60x40 feet, and finished in excellent style. The altar and pulpit are carpeted, and the church furnished with stoves and lamps, a handsome pulpit Bible and a Book of Worship." It is highly commendable that the congregation commenced worshiping in the edifice free from debt.

On the 25th of last September a letter was received from Rev. C. H. Bernheim, communicating the gratifying intelligence that his health had much improved, and that he had received and accepted a call to the Davidson Pastorate. He has since removed to his new field of labor, and entered upon

his Pastoral work.

On the 4th of last November, a communication was received from Rev. N. Aldrich, stating that he had received and accepted a call to become the Pastor of the Evangelical Lutheran Church in Vandalia, Illinois. By Rev. N. Aldrich's removal to Vandalia, the congregation in Charlotte is left without a permanent resident Pastor, but is said to be temporarily supplied with preaching by a Theological Student from North Carolina College. It is hoped that the congregation will at an early day, take the necessary preliminary steps to call a regular Fastor.

On the 13th of February a letter was received from Rev. J. H. Harry, stating, that owing to protracted illness, he had been necessitated to resign the Concord Pastorate, and intended to return to Ohio. In consequence of the failing health of Rev. J. H. Harry, the congregation in Concord is also left without a regular resident Pastor, but, by an arrangement of the Western Conference, is temporarily supplied until the present meeting of Synod. The prosperity of the congregation will readily suggest to the members the necessity of an early adoption of suitable measures to call a regular Pastor.

The constitution confers upon the Synod the authority to form and change Pastoral Districts. In the exercises of this authority, due reference should always be had to the interests of all the congregations constituting a District, and to the efficiency and usefullness of the Pastor in charge.—
This authority should, therefore, be exercised with prudence and prayerful deliberation. It is, nevertheless, a subject of legitimate inquiry on the part of Synod, whether improvements can be made in the present arrangement of Pastorates.

My last official act is now performed. In retiring from office, my sincere gratitude is herewith tendered for your

confidence and partiality, in elevating me to the position which is now vacated.

"And now, brethren, I commend you to God, and to the word of his grace, which is able to build you up, and to give you an inheritance among all them which are sanctified."—Amen.

Rev. W. R. Ketchie, Secretary of North Carolina Synod .:

Dear Sir: The Ministerium of Pennsylvania appointed me delegate to your Synod. It would afford me very great pleasure to attend your meeting, beginning the 28th, inst., but, such is the presure of duties,—the closing exercises of the Seminary, and meeting of our Ministerium, being near at hand,—that, it is simply impossible for me to leave home at this time.

I greatly regret this, and beg, that you will excuse my absence.

Allow me to assure you of the deep interest the Ministerium of Pennsylvania takes in the Synod of North Carolina,—among the oldest, the most useful and most honored of the organizations of our Church in this country,—and to express the hope, that the relations now existing, may not only be maintained, but, become nearer, as the true Lutheran Church takes her rightful position, in the North and the South, the East and the West.

#### Report on the state of the Church.

Your committee, on the state of the Church, would submit the following:

The written reports of the Minutes of this Synod, bring to us glad tidings. They inform us of the fact that our beloved Lutheran Zion, is on the increase in piety, and Chris-

tian perseverance.

They show that the several pastorates in the bounds of Synod are in a healthful and growing condition. The Word has been faithfully preached, and the Sacraments duly administered. New houses of worship have been erected, and con secrated to the services of the Triune God. Sabbath Schools have made rapid progress, hence the religious training of our youth has at least in part been attended to. Extra efforts have been made by pastors and people, the result of which has been the admission of a goodly number to the church, by the solemn rite of confirmation. These indications and facts combined show us that the Kingdom of Christ has been advanced in our midst, your committee have reason to believe that each pastor is doing a great work in the vineyard of the Lord. Let the prayer of Ministers and Lay-delegates go up to the great head of the church: "Lord receive thy work."

Report on Church Institutions and Education.

The following report was received and considered by items. Your committee on Church Institutions and Education

would respectfully submit the following report:

N. C. College is not in as flourishing condition as regards the number of pupils and the extent of its influence as we had hoped it would have arrived at before this time. The number of students is less this year by ten than it was last year. The number in attendance being 105. The causes of the want of this prosperity we conceive to be several. First: the College is not sufficiently advertised in the secular press. Judicious expenditure of printer's ink always brings a rich return. The Merchant, who does not advertise his goods and place of business, cannot expect a large and profitable trade. Again another cause for the want of prosperity, is the absence of an endowment fund, that the teaching force might be increased. The Board of Trustees put into the field an agent for this very purpose, and he collected several thousand dollars. We recommend that this agency be continued until the amount of \$20,000 be raised, as was presented by your committee last year. Another cause for this want of prosperity, is the manner of employing the faculty of the College. They have heretofore been elected by the Board of Trustees with a fixed salary for each one of the Professors, grading these salaries according to the position occupied in the Faculty of the College. We would recommend

that this plan be changed. Let the Professors that are and may hereafter be elected take the College and by their own energy and worth increase the number of their students and pay themselves out of the tuition proceeding therefrom .-The plan heretofore pursued has left undeveloped the latent energy of the corps of Professors, whilst it has gradually but surely involved the College in debt, until it now amounts to \$1 500. There should some provisions be made to meet this indebtedness. Your committee has no plan to suggest for this purpose. There has been a change made in the Faculty of your College, Rev. L. A. Bikle, D. D., has resigned his position as President of N. C. College. The Board have elected Rev. J. B Davis, D. D., as his successor. Prof. H. T. J. Ludwig, also resigned as teacher of Mathematics, and Rev. J. H. Turner has been elected to fill this vacancy. Is it not now to be hoped that if the plan of paying the Professors salaries be changed and with a new Faculty, that the Ministers and Church generally will give the College their hearty support, that it will rise to prosperity and influence, and become an ornament to our Church, of which we will be proud.

The buildings of the College are in bad repair. The late storm has considerably damaged the College buildings, which has been repaired in part, by the help of the friends in the neighborhood. The interior of the buildings are in a bad condition and it will require an outlay of \$400 to \$600 to fix it up properly, which must be done this ensuing vacation. Synod recommend that every Minister lift a collection in each Church for this special purpose at their next com-

munion season.

Nos. 1 a.id 2. Are petitions from six congregations, now served by Rev. W. H. Cone and Rev. R. L. Brown, in which they complain of the arrangement made by the Convention appointed by Synod in 1873, to arrange those churches and the churches served by Rev. P. A. Strobel, into pastoral districts. The petitioners ask Synod to make a more equal division of these churches. In as much as these petitions contain no suggestions, your committee are unable to propose any other arrangement than that which now exists; we therefore, refer these petitions to the action of the Synod,

No. 3. Is a petition from St. Matthew's Church, Davie County, in which they ask to be separated from Rev. Fesperman's charge. Your committee recommend that their re-

quest be granted.

No. 4. Is a petition from Holy Trinity Church, in Mt. Pleasant, asking Synod to be separated from St. John's Church, in order to have more frequent preaching, and also to aid the N. C. College in supporting a Professor. We recommend that their petition be granted.

No. 5. Is a petition from Bethel congregation, Stanley County. We suggest that this paper be read before Synod and such action be taken as the merits of the subject de-

mand.

No. 6. Is a petition from St Michael's Church, Iredell County, praying Synod to dissolve the pastoral relation existing between them and St. Paul's Church, in Iredell Co.—Your committee recommend that their prayer be granted.

No. 7. Is a petition from Harriette J. Scherer, calling aid for Mrs. Sheck, widow of Rev. J. D. Sheck, dec'd., who is in very indigent circumstances and nearly deprived of her eyesight. Your committee recommend that a collection be taken up tomorrow, immediately after sermon, for her benefit.

No. 8 Is a petition from St. Peter's Church, Statesville, asking Synod to supplement their Pastor's salary. Your

committee recommend that a more united effort on the part of the charge of which St. Peter's is a part, will obviate this necessity.

No. 9. Is a petition from Mt. Carmel Church, asking Synod to make some arrangement to supply said Church with preaching. We recommend that this Church be supplied with preaching by the Faculty of N. C. College.

### Report of Committee on Appeals.

The following report was received and considered by items. Your committee on appeals respectfully report as follows: I.—Is a difficulty in the Church council of St. Luke's Church, arising from a case of discipline.

We recommend that the last decision of said council be reversed by the same at a regularly called meeting after due notice having been given to all members of the council.

II.—Is an appeal of M. L. Barringer, from the decision of the church council of St. Michael's Church, of Iredell Co., N. C., expelling him from the communion of the Lutheran Church. Your committee recommend that the action of the said council in this case be reversed and the said M. L. Barringer be restored to full membership in the Church; and for the following reason: Taking said Church Council's own statement charging said M. L. Barringer with "angry looks, boisterous words and threatening gestures," into consideration, without any other testimony, we regard the charge not sufficient for an action of expulsion. We further recommend that Messrs. A. Barringer, M. L. Barringer, their families and all who desire apply to the pastor, be transferred for the present to St. Luke's Church, and all parties concern-

ed to bury the passed, and never, if possible speak again about their grievances.

Report of the Corresponding Secretary.

The following report was received and adopted.

To the Evangelical Lutheran Synod of North Carolina.

It is my duty to report to you my official acts as your corresponding Secretary for the Synodical year, ending 28th, inst.

1. In Feb. last I transmitted to Rev. B. M. Schmucker, D. D., Cor. Sec. of Gen. Council, a copy of the resolutions passed at your last session, relative to the proposed Colloquium. I received a reply to this from Dr. Schmucker, on the 20th of same month, stating that they would be laid before the next meeting of the Council.

2. I received a letter some ten days since, from Rev. E. Canghman, relative to his attending our Synod, and referred the matter to pastor *loci*, who gave it his attention.

3. A number of Synods have favored us with copies of their Minutes. That of the General Council's last convention held at Jamestown, N. Y., 1874, exhibits a gratifying progress in its membership and various enterprises. The Holston Synod was received as a member at this convention. The officers of the previous year, Rev. C. P. Krauth, D. D., L. L. D., bein, the President, were re-elected. The Council is doing a good work in home and foreign missions. Hopes are still entertained that the much looked for Colloquim will be held. The Council numbers 12 Synods, 660 Ministers, 1,231 Congregations and 177,174 Communicants.

4. A copy of Minutes of Tenn. Synod. There is nothing in it that specially concerns this body. Our delegate Rev. W. Kimball, was cordially received, and as delegate to our Synod, Rev. Timothy Moser, was appointed, whom I am pleased to see present with us. The Synod is harmonious and prosperous. Rev. L. A. Fox is President, Rev. A. L. Crouse, Rec. Sec. and Rev. J. M. Smith, Cor. Sec. Its next meeting will be held in Mt. Calvary Church, Page Co., Va., on Thursday before the first Sunday in Oct., 1875.

5. The Minutes of S. C. Synod. This body is successfully engaged in the work of building up the Church in its bounds.
